Holidays such as Christmas, Easter and Lent are not considered events. Therefore, temporary licenses will not be issued for holiday seasons. Applicants must obtain temporary licenses for each qualifying event being conducted during a holiday season.

I further acknowledge and understand that Hartford has a mandatory training provision in its ordinance that requires all persons involved in the serving of alcoholic beverages by the drink participate in and complete a responsible beverage service training program within thirty (30) days in which the person first becomes subject to training. I certify that this requirement is being or will be met.

I do hereby solemnly swear or affirm that all statements contained in this application and all attachments are true and correct to the best of my knowledge, information and belief. I understand I may not begin to operate with alcohol activity until both a state and city license(s) has been issued. I further swear or affirm I shall abide by all state and local statutes, regulations and ordinances relating to the sale, use or trafficking in alcoholic beverages. I hereby authorize the release of Police and/or Criminal records to the City of Hartford ABC Administrator.
